# RELEASE OF LIABILITY

This agreement is between **(Student's name)** \_\_\_\_\_; Life Ki-do LLC, Austin Martial Arts Academy; Empty Hands Incorporated; camp programs; its volunteers; its instructors; and all other employees, hereinafter collectively referred to as Life Ki-do or LK.

In consideration for enrollment in LK programs, the parent(s) and/or legal guardian(s) of the minor are consenting for the minor to participate in LK camp and make the following statements and promises:

1. I acknowledge before signing this agreement, that many of the techniques taught in LK programs are intended strictly for self-defense and physical fitness purposes, and that these techniques are not to be used in a negative or aggressive manner against any person or property. I understand that my child may be expelled at any time from participation in a program or event if the instructors learn that my child used these techniques in a negative or aggressive manner against anyone or anything.
2. I agree that this agreement shall be binding upon my heirs, next of kin, representatives, and assigns and that they: (a) will not make a claim against LK for any injury, death, or property damage resulting directly or indirectly from my child's participation in a LK program or event; and (b) will release and discharge LK from any claims or demands arising from injury, death, or property damage to my child caused by his/her participation in a LK program or event.
3. I am aware that participation in LK programs can involve strenuous physical activity and I understand that training could involve physical contact between students, instructors and training equipment. I understand that my child may be participating in simulated self-protection scenarios that may be physically and/or emotionally stressful. With this knowledge, I voluntarily assume the full risk and responsibility for any and all psychological and/or bodily injury, death, or property damage arising from the actions or conduct of LK, its instructors, or other students; from my child's actions or conduct during a LK-sponsored event; or from my child's actions or conduct as a LK student however caused and whether caused in whole or in part by the negligence of the Releasees named above.
4. I promise to defend, indemnify, and hold harmless LK from any claims made by third parties alleging injury or damage resulting from my child's conduct and activities while on LK, West Austin Youth Association or O. Henry Middle School premises or during a LK sponsored event, from my child's conduct as a LK student, and from my child's use of any techniques learned in a LK program.
5. I agree to allow LK to use my child's still or moving picture for any promotion and/or publicity relating to LK. I understand that I will not receive any compensation for such use.
6. I have not requested nor received any warranties as to the effectiveness of any LK program.
7. I agree that there have been no oral representations, statements, or inducements made apart from this written agreement.
8. I understand that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the state of Texas and that if any portion thereof is held invalid, I agree that the balance shall, notwithstanding, continue in full force and legal effect.
9. In the event of an injury, condition, or death that surpasses the capabilities of our instructors, I hereby give permission to obtain qualified emergency medical assistance to my son/daughter and do not hold Life Ki-do, Austin Martial Arts Academy, West Austin Youth Association, O. Henry Middle School, or any Independent Contractors liable for such occurrence. I also understand that injuries received may be compounded or increased by negligent rescue operations or procedures of the Releasees.
10. I have carefully read this agreement and fully understand its contents. I am aware that this agreement is a release of liability and responsibility between myself and Life Ki-do LLC, Austin Martial Arts Academy; Empty Hands Incorporated; camp programs; its volunteers; its instructors; all other employees and affiliated members. I voluntarily agree to each of the terms and provisions thereof and sign this agreement on my own free will.

# **LIFE KI-DO KARATE CAMP POLICIES AND PROCEDURES**

**(Please Read & Keep a Copy of this Information)**

## **Cancellations and Refunds:**

A non-refundable processing fee of \$25 is included in the price of camp tuition. If you cancel less than 3 weeks prior to the start date of the camp, you will only receive a refund less the \$25 processing fee if we are able to fill your spot. There is no prorating of fees for missed classes or for late enrollments. Failure to attend does not constitute a refund or cancellation and returned transactions are subject to a \$25.00 returned transaction fee.

## **When to Arrive:**

Please arrive promptly at 9:00 am so camp can begin on time.

## **Pick Up/Drop Off:**

For your child's safety, you will be required to escort your child into the building and sign in and out each day. Your child will be released only to those authorized by you. Photo identification may be required. Camp will meet promptly @ 9am. Rooms are not available for camp until 9 am, so please NO EARLY DROP-OFFS. ;- ) Camp pick up is at Noon. (Late Pick up is \$1 per minute.)

## **What to Wear:**

Campers should wear comfortable clothes that will allow them to move freely and fully engage in all activities - loose comfortable play clothes for indoor/outdoor use are best. Wear tennis shoes for outside playtime. Bring a light wind/rain jacket. Always wear and bring sunscreen. Each camper will receive a Karate T-shirt as part of tuition.

## **What to Bring:**

Please send your child with a "full breakfast belly" to have the most energy for their karate day. As each child's eating habits vary, please send enough hearty and healthy snacks and labeled juice boxes or water for the appropriate amount of time for your child's appetite. There will be a mid-morning snack break.

## **Minimum Class Enrollment:**

In the event that a minimum number of students have enrolled, sessions may be cancelled, combined or postponed.

## **Substitution:**

Life Ki-do reserves the right to substitute or replace teachers.

## **Medications:**

I understand that if my child needs to take any prescription medication, a parent/guardian must personally administer such medication.
